She is the author of the research monograph, *Rethinking Unequal Exchange: the global integration of nursing labour markets* (2012), and authors' editor of *The Future of Mining in South Africa: Sunset or Sunrise?* (2018). She has also published on health, economy, and labour in a range of policy papers, journal articles, and popular articles. She was awarded the Feminist Economics Rhonda Williams Prize in 2012 – an award recognising feminist scholarship and activism in the spirit of the African American economist and advocate, Rhonda Williams.
